The ability to safeguard small to mid-sized enterprises will open up an exciting market for CyOps. According to the Cyber Crime Division of the FBI, "there are tens of thousands of attacks daily and many network breaches are not made public."

In 2010 CyOps FSD will launch two new service offerings that will further safeguard clients from security threats while mitigating risk.
